## Parent/Carer Consent

### Routine Visits

School/establishment: **Llantrisant Primary School**

During the school year, we will plan educational visits and activities for the pupils to enhance their learning experiences. Rather than send consent forms for each visit/activity, we are sending out this annual consent form. Trips/activities generally relate to class themes, sporting activities and transition visits with the comprehensives. They will normally take place during school hours to such places as:

- Anywhere in Llantrisant, e.g. local church or chapel, shops, park, Llantrisant Common, the Billy Wynt, Llantrisant Castle, Llantrisant Leisure Centre, farms/small holdings, local sporting fields, other local schools (*You will be informed if your child is selected to represent the school in any fixture*).
- The following venues have been and are regular destination school trips and as such are felt NOT to require specific consent for participation; St.Fagan's, Techniquet, Rhondda Heritage Centre, Caerleon, The Roman Baths, The Big Pit, Theatre trips, Cardiff and Swansea Museums, Cardiff Bay, Margam Park, Cog moors, Y Pant/BrynCelynnog Comprehensives

Neither list is exhaustive but all are routine.

- Walking in small or class groups suitably supervised to local points of interest or sporting matches; being transported by mini bus (or volunteers with cars to inter school events and sporting matches;
- Short range bus trips usually within 40 mins., but up to 90 mins.

As a school we endeavour to keep the cost of any trips/visits to a minimum, however, we ask for a contribution to cover the cost of admission fees and transport where it is applicable. Without these contributions the school is unable to fund these additional learning experiences and activities.

**I understand that:**

- Such visits will normally take place within the school/establishment normal hours, but that if, occasionally, they are likely to extend beyond this, adequate advance notice will be given so that I may make appropriate arrangements for my child's return home.
- My specific permission will be sought for any visits beyond those listed above or which could involve commitment to extended journeys, times or expense.
- All reasonable care will be taken of my child during the visit.
- My child will be under an obligation to obey all directions given and to observe all rules and regulations governing the visit and will be subject to all normal school/establishment discipline procedures during the visit.
- I must inform the school/establishment of any medical or behavioural condition or physical disabilities that may affect them during the visit.
- All young people are covered by the Local Authority's third party public liability insurance in respect of any claim arising from an accident caused by a defect in the school/establishment premises or equipment or attributable to negligence by the Council or one of its employees. Please note that this insurance policy does not include personal accident or personal belongings cover for your child.
